# What is Friends of Raymond James?

Friends of Raymond James, Inc., is a 501(c)(3) nonprofit organization established to provide assistance to associates of Raymond James in times of unforeseen hardships resulting from catastrophic personal tragedy or emergency.

For almost three decades, Friends of Raymond James has disbursed over \$2.3 million to assist more than 500 Raymond James associates during times of need.



# Our history

In 1997, tragedy struck when a Raymond James associate unexpectedly passed away, leaving behind two children. Friends and coworkers felt the need to do something to honor his memory, as well as assist his children to help ensure their futures. This financial need, coupled with the associates' desire to make a difference, became the inspiration for what is now Friends of Raymond James.

The success of their fundraising efforts moved them to bring the same relief to other colleagues who found themselves faced with personal catastrophe.

To address the need of associates facing difficult times, Friends of Raymond James, Inc., was established in 2000 and incorporated as a 501(c)(3) nonprofit in 2002. In 25 years, Friends of Raymond James has done much more than its founders could have ever anticipated.

## Who we've helped

Financial assistance has ranged from a few hundred to thousands of dollars to cover a variety of expenses, such as:

- Housing bills following a natural disaster
- Hospital bills due to an unexpected illness
- Support after the loss of a loved one
- Medical and living expenses due to fatal illnesses
- Assistance with funeral costs
